

Long Term Care Facility Enforcement Report

This is a year-to-date enforcement report for Medicare and/or Medicaid certified long-term care facilities reporting the status of actions initiated. This report includes remedies recently proposed as well as those that have been actually imposed by the Director of Health and/or the federal Centers for Medicare & Medicaid Services. The purpose of the report is to answer the many public information requests that we receive regarding facilities that face or have faced enforcement actions for non-compliance with certification standards.
