OVERALL ACTIVITIES COVERED BY FUNDS SOURCE:

CFHS consultants and administrators reviewed seventy(70) continuation grant applications for SFY11. The Child and Family Health Services (CFHS) program is designed as an organized community effort to improve the health status of women and children in Ohio by identifying needs and implementing programs and services to address identified needs. CFHS goals are to be accomplished by engaging in a focused, multidisciplinary, collaborative approach to health improvement in coordination with internal and external stakeholders that serve racial and ethnic groups disproportionately affected by poor health outcomes, including, but not limited to, local public health agencies, community health centers, community-based organizations, faith-based organizations, Regional Perinatal Centers, private sector organizations and other public health providers.

REVIEW CRITERIA USED FOR SELECTION:

The review criteria was based on the quality of the Executive Summary, Description of Applicant Agency, Documentation of Eligibility, Personnel, Problem/Need,(including Collaboration, Eligibility and Justification, Community Health Assessment Process,& Priority Population), the CFHS Program Plan, Cultural Competency, past performance, and the Budget Narrative (including the CFHS Budget Summary Sheet & GMIS Budget Narrative).

Vinton County Health Department was the only existing subgrantee who did not reapply. Seventy (70) CFHS continuation grant applications were reviewed & approved.
