Specifically, goals of Part C ARRA funds are to preserve or create Part C related jobs, such as service coordinator and/or child find positions; and to stabilize the state and county Part C budgets; to minimize and avoid reductions in essential Part C services; and to further the goals of the Help Me Grow early intervention program. By June 30, 2011 the Help Me Grow Program will create or retain an estimated 10% more jobs in the state of Ohio to provide Part C services to eligible children than would have been possible without the ARRA funding.

All proposals will be judged on the quality, clarity and completeness of the application. Applications will be judged according to the extent to which the proposal meets the goals of and guidelines for implementing ARRA.
