Registration:

Registration will be available utilizing OhioTRAIN. To register, go to OhioTRAIN at <https://oh.train.org>. If you have not used OhioTRAIN before, go to "Create Account" on the website and follow the directions. Once you are in OhioTRAIN, enter the number **1065420** in the search box. You will see the conference title "**2017 Ohio Department of Health Regional School Nurse Conferences.**" Please click on "**Add**" button to choose your conference location (Reynoldsburg, Wooster or Beaver Creek).

- Friday, March 3, 2017, for Wooster at Shisler Conference Center at The Ohio State University (Friday, March 10th)
- Friday, March 31, 2017, for the Beavercreek location (April 7 at the Soin Medical Center)
- Or until facility capacity is reached (whichever comes first)

Registration and fees must be received by the dates listed above. A confirmation e-mail will be sent upon receipt of your payment. Due to space limitations, confirmation is necessary for you to attend the conference; no phone, fax or walk-in registrations can be accepted.
