

Ohio Department of Health MDS 3.0 Advanced Training Information

DATES OFFERED: 1/28/16, 2/25/16, 3/24/16

LOCATION: These training sessions are conducted at the Ohio Department of Health (ODH), 35 E. Chestnut Street, Columbus, Ohio 43215. Please bring a warm jacket or sweater as the temperature of the room cannot be controlled. The training will be in the basement, Training Room A/B.

TIME: **Registration begins at 8:00 a.m.** Training begins at 8:15 a.m. to 4:45 p.m. Two breaks and lunch are scheduled and will be the responsibility of the participant. There is an ATM on the premises, near the training room. The deli located onsite does not accept credit cards. You are welcome to bring your own food.

WHO SHOULD ATTEND: This training is for Ohio nursing home personnel who are **actively involved** with the completion of the Care Area Assessments and development of the Care Plan. **The Advanced Training is for the members of the IDT who are responsible for Care Planning.** This training is not for people who are not employed by a nursing home and/or not completing the required MDS assessments. **The prerequisite for this class is completion of an Ohio Department of Health Basic MDS Training class. These classes are scheduled throughout the year.**

OVERVIEW: Participants will receive training on the overview of the RAI and Care Area Assessments. They will be provided with knowledge about triggering the Care Areas and writing a Care Plan. Any changes to the MDS and other areas of need will also be offered if necessary.

PREPARATION FOR TRAINING: In preparation for this advanced training, please read the MDS 3.0 manual – particularly Chapter 4 and Appendix C. TO REGISTER: The DON or Administrator must register you using a personal email account. If neither the DON or Administrator have an account in the Ohio Department of Health system, they will need to go to <http://publicapps.odh.ohio.gov/eid> and select "EIDC User Account Request". Follow the directions and they will be notified within 24 hours with a User ID and a Password. After they receive the email with the User ID and Password, they go to the DQA Event Registration at <https://odhgateway.odh.ohio.gov> to register you. When registering, they should enter a personal email address where you, the trainee, can be notified of any changes after registration.

If any registrant cannot attend please had the DON or Administrator go back to the registration and delete your name as soon as possible to make room available for others. Registration will be shut off at the close of business on the Monday before the class.

Because of limited space, reservations are mandatory. Reservations are limited, and no one will be admitted without prior registration. There will no substitutions of people who are not registered on the EIDC account for this training.
